

EASIPHEN

DESCRIPTION

A phenylalanine free liquid containing a balanced mix of the other essential and non-essential amino acids, carbohydrate, fat, vitamins, minerals and trace elements. Available in Forest Berries flavour.

INDICATIONS

For the dietary management of proven PKU in children over eight years and adults.

PREPARATION AND ADMINISTRATION

Easiphen is best served chilled. Shake well before consumption.

ADMINISTRATION GUIDELINES

The dosage should be determined by a clinician or dietitian only and is dependent on the age, body weight and medical condition of the patient. The daily intake of protein substitute should be taken in divided doses throughout the day.

GENERAL PRECAUTIONS

Use under medical supervision. Not for parenteral use. Not suitable for use as a sole source of nutrition. This product should not be used as a sole source of protein but must be given in conjunction with a protein source, to supply the phenylalanine, fluid and general nutrition requirements of the patient in quantities as prescribed by a clinician or dietitian. Only intended for use by patients with PKU.

STORAGE

Store at room temperature away from sunlight.
